Qualifying electric vehicle (EV) chargers must be purchased between July 1, 2019 and December 31, 2020.

Qualifying EV charger purchases must be new, Level 2 (240-volt) EV chargers; used EV chargers are not eligible for rebates. Only one rebate per EV charger. Installation costs will not be applied towards the rebate amount. Rebate forms must be submitted within 60 days after the installation of the EV charger. To receive a rebate, this form must be completed in its entirety, and a copy of the sales receipt and photo of the installed EV charger must be included. Physical inspection for verification may be required. KUB reserves the right to verify sales receipts, model numbers and installation information. KUB also reserves the right to request additional documentation. By submitting this form, you agree to the terms and conditions of this offer.
