Re: Traffic Advisory – Road/Lane Closure for Utility Work [All closures and work are weather permitting]

Downtown Century II Utilities Upgrade Project – Walnut Street Lane Closure [Extended October 3] – KUB and its contractor crews will reduce a short section of Walnut Street between Union Avenue and Summer Place to one alternating lane of traffic from 7 a.m. – 6 p.m. on Monday, October 3, as work continues on the Downtown Century II Utilities Upgrade project. The northbound lane will be closed, while the southbound lane remains open and is used to alternate traffic through the work zone. Access to area parking garages will be maintained. Follow-up advisories will be issued as necessary.

(South Knoxville) Rugby Avenue Southeast Lane Closure [October 3] – KUB contract crews will reduce Rugby Avenue Southeast to one alternating lane of traffic from 7 a.m. – 4 p.m. on Monday, October 3, as work is performed on the water distribution system in the area. The westbound lane will be closed while the eastbound lane remains open and is used to alternate traffic. Flaggers will be on site to assist with traffic control, and follow up advisories will be issued as necessary.

(North Knoxville) Charles Drive Road Closure [October 3-14] – KUB contract crews will close a short section of Charles Drive to through traffic between Inskip Road and Montrose Road from 7 a.m. – 5 p.m. daily, Monday-Friday, as work is performed on the wastewater collection system in the area. Alternate routes include E. Inskip Road, Fair Drive, Montrose Road, Maple Drive, and Highland Drive. Local traffic access to driveways will be maintained. Flaggers will be on site to assist with traffic control.

Some listed closures may extend beyond the scheduled times depending on the conditions encountered during excavation and construction. Appropriate traffic control measures will be in place at each location to assist motorists traveling in these areas. Due to the ongoing presence of workers and equipment, motorists are advised to use caution and expect temporary delays in these areas. Tennessee's **Move Over Law** requires motorists approaching a utility vehicle with flashing lights to move over if safe to do so, creating an empty lane buffer. When changing lanes is not possible, motorists must reduce speed.

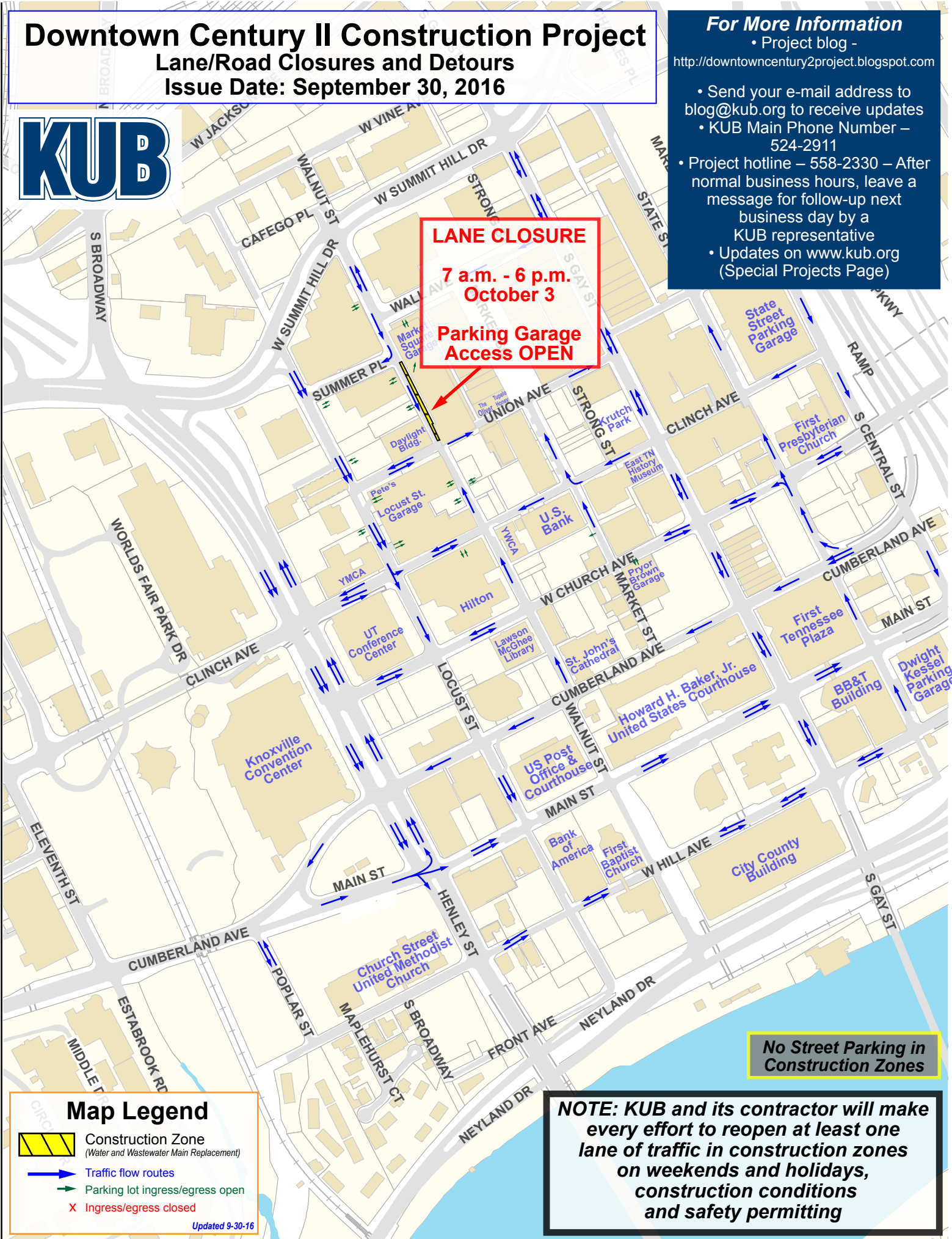
